SUBJECT: NRA/Winchester Cadet shooting program

The following are details on the NRA/Winchester Rimfire Rifle Benchrest Course, using .22 caliber bolt action rifles. For more information, go to <https://mqp.nra.org/media/4206/rimfire-rifle.pdf>.

1. The course will be conducted at the Black Rock Fish & Game Club range, Mountainville, NY 10953.
2. Uniform is BDU or ABU. After range time, these uniforms should be washed to remove any residue from shooting.
3. Shooting dates are on Wednesdays and Thursdays as follows: July 17, 18, 24, 25, 31, Aug 1, 7, 8, 14, 15, 21, 22, 28, and 29. Please indicate all dates available on the online signup form and you'll be notified which dates you'll be shooting.
4. A comprehensive safety brief will be given prior to shooting on each date. Safety is FIRST. The shooting will be conducted by certified NRA Rifle Instructors and will be overseen by a certified NRA Range Safety Officer.
5. The report time for all dates is 0900 in front of Starbucks, 113 Temple Hill Rd, New Windsor, NY 12553. Cadets/parents will meet a CAP Senior Member at Starbucks and follow him to the range. Ending time is estimated to be 1300. We'll be breaking for food and water, so pack a lunch.
6. Parents MUST accompany Cadets. No parent - no shooting. Parents should bring folding chairs for comfort. You will be observing all shooting.
7. Parents and Cadets MUST have eye protection and hearing protection. Eye protection can be prescription eyeglasses. Ear muff type hearing protection is mandatory. Each person should have their own for personal health reasons.
8. Parents should bring water to drink and hand cleaning towels for themselves and Cadets. This will clean residue from hands after shooting. It will probably be hot, so water is important.
9. Rifles and targets will be provided at the range.

10. Ammo will be purchased at the range, which is estimated to be \$8 to \$10.
11. Cadets and parents are responsible for keeping their targets/scores for future ratings in the Benchrest course.
12. Parents will be able to purchase NRA certificate packs for \$6.50 per rating, which includes a medal that can be worn on the CAP Blues uniform. Information on how to order will be available at the range to those interested.
13. Cadets must give 48 hours notice if they won't be shooting by calling me. If it's raining, we will not be shooting and a make-up date will be given.
14. CAP ID card and CAP Form 60-80 must be presented at range prior to shooting.
15. We are representing Civil Air Patrol at this range. No horseplay or actions unbecoming a Cadet will be tolerated. We are being given a great gift from the Black Rock club, let's have fun.
